We, the undersigned, as Directors of the Board of Stress and Grief Relief, Inc., are writing this letter in support of Dr. Joyce Hunt Brown's application for Certified Crisis Chaplain with the American Academy of Experts in Traumatic Stress. We can confirm that Dr. Brown has been working in the capacity of a chaplain as an instrumental part of her role and responsibilities as the President and CEO of Stress and Grief Relief, Inc. since it's incorporation in April 1999.

The determination to designate Dr. Brown as a chaplain was made in order to better facilitate her work with area schools, prisons and juvenile detention centers, where she has been volunteering her time coaching people struggling with traumatic stress, anger, depression, suicide and grief even before she founded Stress and Grief Relief, Inc. nearly twenty-three years ago.

Prior to Dr. Brown adopting the designation of chaplain, an initial inquiry was made with the state of Utah in 1999 by Leon Halgren, esq., a former Board member of Stress and Grief Relief, Inc., who had also formerly served as an Assistant Attorney General for the state of Utah. At that time, Mr. Halgren learned that there were no official requirements for certification for chaplains in Utah.

It is also worth noting that most all of the chaplain certifying bodies that exist today did not exist at the time that Dr. Brown began working as a chaplain for Stress and Grief Relief, Inc., as confirmed by the following:


1. The Board of Chaplaincy Certification, Inc. was founded in 2001.
2. The International Fellowship of Chaplains was founded in 2001.
3. The Association of Certified Christian Chaplains was founded in 2007.
4. The National Chaplains Association was founded in 2010.
5. The common qualifications and competencies of the chaplaincy profession were affirmed by the constituent boards of the Council on Collaboration on November 7, 2004



### American Institute of Hypnotherapy

The American Institute of Hypnotherapy was an educational establishment based in California (School no. 3004761) with the approval of, and under the jurisdiction of, the California Bureau for Private Postsecondary Vocational Education.

The Bureau for Private Postsecondary Vocational Education was the California state agency vested with the authority to approve and regulate private postsecondary institutions in California. The Bureau for Private Postsecondary Vocational Education was charged by the California legislature with the mandate to encourage the development of strong, vigorous and widely respected sector of private postsecondary education.

After a review, the State of California's Bureau for Private Postsecondary Vocational Education determined that the American Institute of Hypnotherapy met the standards established by the bureau for integrity, financial stability and educational quality. Therefore, under California law, the American Institute of Hypnotherapy was licensed to teach and issue degrees and doctorates in the special field of Clinical Hypnotherapy.

The California practice of recognizing specialist institutions for particular disciplines allowed the American Institute of Hypnotherapy to offer their facilities for practical training and off-campus study in Clinical Hypnotherapy. In order to obtain the doctorate, students must have attained a Bachelor Degree level of education from an approved educational institution.

A diverse curriculum was offered by the American Institute of Hypnotherapy across the fields of healthcare, psychotherapy, self-development and business applications of hypnotherapy.

The American Institute of Hypnotherapy offered a wide range of hypnotherapeutic course modules, including Personal and Professional Ethics, Self-Hypnosis Techniques, Creative Visualization, Modern Hypnotherapeutic Techniques, Understanding Emotional Stress, Communication Skills for Hypnotherapists, Hypnotherapy in Sports, Principles of Behavior Modification, Cognitive Behavioral Change, Hypno-analysis, Medial Hypnosis, History of Hypnotherapy, Neuro-Linguistic Programming, Imagery in the Health Professions, Brain Physiology and many more. For each module research had to be completed and an original paper was required to be submitted.

The American Institute of Hypnotherapy was approved from 1982 until 2007 when a major restructuring of the way post-secondary education was delivered under the Arnold Schwarzenegger government. The State of California's Bureau for Private Postsecondary Vocational Education ceased to exist in 2007.

## JOYCE HUNT ... profile

When she stood up to address the panel on legislation at the recent National Gasohol Commission meeting in Columbus, Joyce Hunt commanded attention—and pindrop silence. The almost all-male audience listened, intently not so much because she was a very attractive lady, but because she commanded attention by virtue of what she was saying. More stress had to be put on using recycled energy—if one were to permit the term—and less on making alcohol without attention to the energy source. The laws were skirting the issue, Hunt said.

Joyce Hunt knew whereof she spoke. In home base Utah, she is well known and respected as a business executive in an unusual occupation. She is the developer of a recycling center at the Weber Waste Disposal Complex. She is adamant in her contention that other nations are well ahead of the U.S. in developing alternatives to fossil fuel, gasohol included. Her view on alcohol is equally to the point. "The best place for alcohol," she says, "is in the fuel tanks of automobiles."

A broad-spectrum problem is troubling Joyce Hunt, and it is continuation of that problem that brings her to her feet at trade assemblies. Scientists and engineers, she says, are taking back seats to those in the political arena. "I have been impressed with advancements in other countries as to the use of

fuels not derived from petro chemical sources," she said.

Joyce Hunt has been working in private industry for the development of resource recovery and conversion of alternative fuels. The Hunt project in Weber County is well on the way toward producing an alternative to mined natural gas. Hunt believes resource recovery fuels have an important role to play in the emerging gasohol industry. Her efforts have been crowned with the kind of success that comes from thinking ahead. This has meant finding a need (market) and filling it. The anatomy of making it happen has to do with more than recognizing that the energy is there. "It is, of course," Hunt is quick to offer. "Two pounds of solid waste contain as much BTU value as a pound of coal." That's pretty good for a start."

Foreign government leaders and scientists, she said, cannot understand why the biggest energy user—the United States—lags behind, although the people appear to be determined to become more energy self-sufficient.

"It was obvious," she said. "they expected Americans to be innovative and wondered why we weren't leading in this area as we have in so many other things."

There is no argument, Hunt said, that each country should develop the potential of fossil fuels—including oil

shale in Utah—"But it is more than just good economics to develop fuels from renewable sources first."

She believes the nation is in an "insecure position to have an economy totally dependent upon foreign energy and thereby be controlled by those in lands abroad."

The project at West Ogden—to market salvageable waste—is a part of an energy program. "One of the most dangerous things we can do is to close our eyes to the use of alternate fuels such as methanol, ethanol and refuse derived fuel from garbage," Hunt said.

Hunt believes that tax credits to industry that takes a chance on gasohol and the creativity of Americans could turn around the nation's economy and growing unbalance of foreign trade payments.

Those who want to learn a bit more about reclaiming value from garbage and solid waste are always surprised to learn that the voice behind J. E. Hunt & Associates, Murray, Utah, is a very lovely lady with a superb business sense in tow.



## County Landfill Leads in Solid Waste Recovery

Weber County is ahead of other entities in Utah in planning for recovery of solid waste at the incinerator and landfill complex in West Ogden, said Ogden Councilman Scott Sneddon, chairman of the solid waste advisory board.

Sneddon said he and other elected officials in the county are looking forward to studying the possibility of the complex being recognized as a regional waste disposal facility.

An average of 450 tons of garbage a day is processed at the center for disposal or recycling.

If the operators of the county-owned complex, J. E. Hunt and Associates and Teledyne National, are able to collect another 100 tons a day from nearby communities, a \$12 million revenue bond will be issued late this year or early in 1981, Sneddon said.

Possible sources include Davis County that operates two landfills and Hill Air Force Base that has contracted through 1981 with Davis for disposal.

Resource recovery by conversion of solid waste into marketable use saves energy and brings a return from the sale of fuel derived from garbage or steam generated and sold for heat and power sources for homes and industry, Sneddon said.

Discarded rubber tires, once buried in the landfill are saved, as are cardboard, aluminum cans and ferrous metals.

Joyce Hunt of J.E. Hunt and Associates received the bid to operate the county-owned facilities in May 1978 with a 40-year contract that provides for the sharing of 50 percent of the revenue with Weber County.

Hunt hired Teledyne National, based in Northridge, Calif., a subsidiary of Teledyne, Inc., to manage the complex. Teledyne National operates similar waste recovery facilities in other areas

of the nation and abroad.

Under terms of a 40-year contract signed by the Weber County Commission, Hunt-Teledyne is paid a fee based on tonnage of waste. Commercial haulers paid \$5 a ton with a \$3 minimum and \$30 maximum load charge. The county shares in the revenue from the tipping fees as well as the sale of recovered materials.

Sneddon is chairman of the board of elected officials representing each city, except Plain City, that uses the complex.

The goal is not to landfill, but to recycle and recover waste, said Ms. Hunt. Today almost 72 percent of incoming solid waste is processed and shredded followed by the separation of ferrous metals by means of a magnetic separator.

The remaining shredded refuse is combusted in a fired furnace or incinerator equipped with an electrostatic precipitator to control air pollution.

Ferrous metals have a market, Proler International of Provo is a customer.

U.S. Steel has also bought the ferrous for a test as a feedstock to open hearth furnaces.

Hunt-Teledyne plans to market refuse derived fuel for use in boilers.

A federal Environmental Protection Agency official visited the West Ogden site recently and said, in his opinion, the landfill has at least a life of 20 more years.

Sneddon said the landfill's use could be extended once the complex is equipped for "total waste recovery."

The city councilman said the County Commission 14 years ago had good foresight in acquiring the West Ogden land from Union Pacific Railroad and others to build incinerators and set out space for disposal of materials that can't be burned.

"The waste disposal center is

run under strict standards imposed by both the state and federal environmental protection authorities," Sneddon said.

As an example, Hunt-Teledyne refuses to accept any hazardous or toxic wastes and monitors closely material dumped at the site.

Ms. Hunt said she arranges with companies or municipalities for the shipment

of toxic wastes placed in covered barrels to a site in Northern Nevada or Southeastern Idaho.

Sneddon said a Wasatch Front Regional Council study of waste disposal sites indicates the Weber landfill will be studied for upgrading to meet criteria for the flood plain, surface waters nearby, groundwater, eradication of rodents and certain po-

tential hazards.

The Wasatch Front study pointed out inadequate drainage for water in ponds over parts of the landfill, but the EPA says there is no known pollution of groundwater from the landfill and does not expect the downward migration of leachate of ash from the incinerator.

The landfill is not used for open burning, a practice at some other disposal sites, and since

Teledyne National took over management accidental underground fires have been few.

Operating costs of the Weber disposal facility — landfill, incinerator, partial waste recovery — totaled \$773,433. Labor expense amounted to \$605,165, maintenance \$168,585 and depreciation \$43,000. Capital improvements totaled \$228,055. Salvage revenues came to \$168,647.



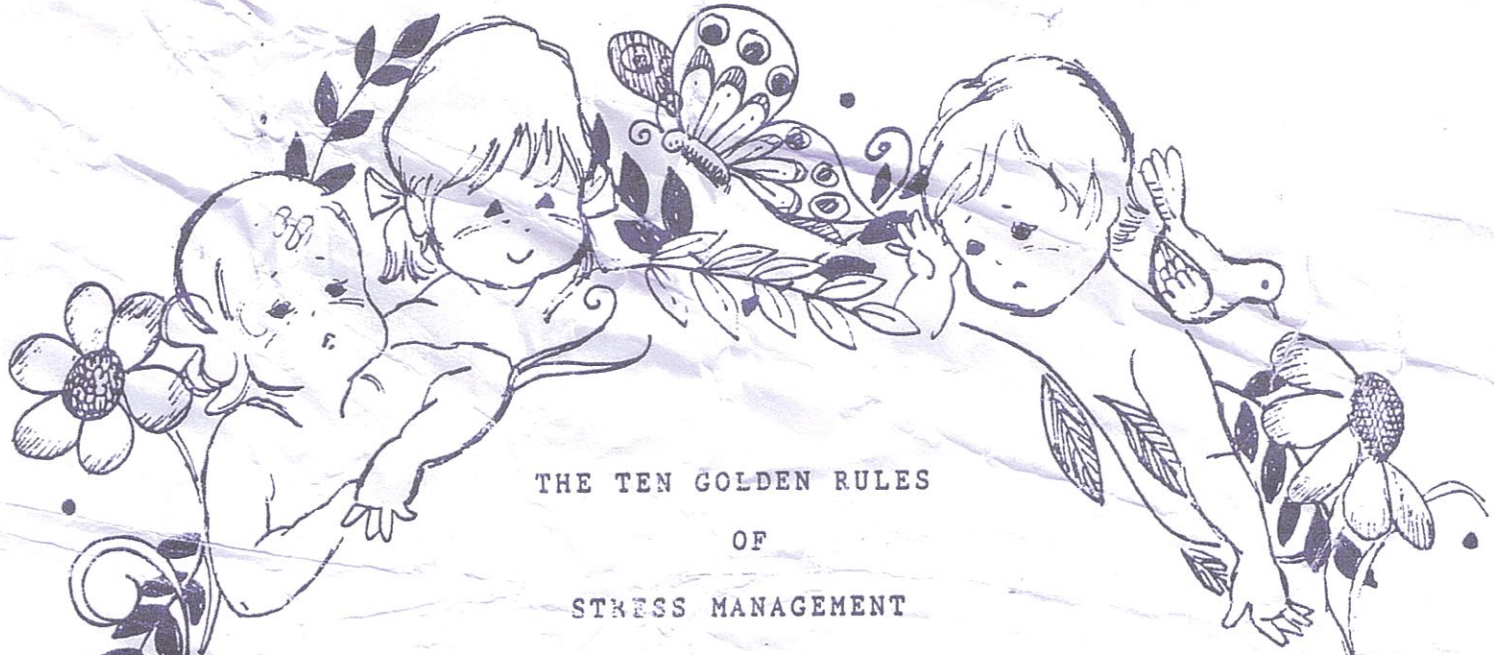
